# **Southwest Iowa Outfitters Waiver of Liability**

I (print name) \_\_\_\_\_, on behalf of myself, my family, heirs, assignees and estate, in consideration of the opportunity to hunt on any property (owned, leased, rented, or just having permission to hunt) by Southwest Iowa Outfitters and with full knowledge of the inherent dangers of hunting even when taking all reasonable safety precautions, do hereby release any absolved of all liability to Southwest Iowa Outfitters, its founders, members, agents, and representatives, any and all land owners, or persons farming the property from any and all liability for any injury, damage, or harm including but not limited to my death.

### **Rules and Agreements**

- 1. I have been informed by Southwest Iowa Outfitters that I am required to wear my safety harness at all times when hunting out of tree stands. Any failure to do so will be considered the hunter's (who signs this form) negligence if an accident or injury occurs.**
- 2. I agree that I am entering all properties, elevated blinds, elevated tree stands, and ground blinds at my own risk. Any injury or death that may occur will be the hunter's (who signs this form) fault and not Southwest Iowa Outfitters fault.**
- 3. I agree that any buck that I kill including but not limited to: Button Buck, Shed Horn Buck, Spike Buck, or any Antlered Buck will result in a management penalty fee of \$1500. Any antlered buck taken will be turned into the Iowa DNR and hunter will be responsible for any fines or penalties administered by the Iowa DNR.**
- 4. Any hunter that wounds an animal or draws blood on an animal is considered tagged out on their hunt. If the animal is not found the hunter may hunt another doe for another \$250.**

5. At the time of signing this form the balance of the amount of the hunt will be paid in full.
6. I agree that I fully understand and will abide by state and federal hunting laws and regulations as well as the rules and agreements with Southwest Iowa Outfitters
7. Southwest Iowa Outfitters has the right to ask any guest to vacate the lodge at any time with no refund if the guest does one of the following acts: Including but not limited to: Destruction of any of Southwest Iowa Outfitters property or land, breaking any hunting laws, causing problems with other guests or owners of the lodge, breaking any rules on this form or any other rules added during the hunt by Southwest Iowa Outfitters, or being an unpleasant guest in camp.
8. I agree that Southwest Iowa Outfitters has done everything in their power to make my hunt as safe and successful as possible.
